Responsible Pet Ownership Contract

Peekapoo Zone Puppies raise only first-generation Peekapoo Puppies. We require the new owner of the puppy to neuter or spay on or before six months of age or at the time indicated by a veterinarian.

From Peekapoo Zone Puppies

In some cases, families may be unable to care for their puppy and choose to give it to a family member. Unfortunately, that family member may not provide proper care, which can lead to neglect and unplanned breeding. Puppies born from these unwanted litters are often given away carelessly, continuing a harmful cycle.

Over time, these dogs may end up sick, abandoned, in shelters, or even deceased. In some situations, people breed puppies irresponsibly, without understanding the true responsibility involved, causing unnecessary suffering and hardship for the dogs and their puppies.

For this reason, we strongly encourage all puppies to be spayed or neutered while in your care. We understand that encouragement alone is not always enough, and therefore spaying or neutering is required. By spaying or neutering your puppy, you are helping to stop this painful and ongoing cycle.

For The Owner

It is your responsibility to notify Peekapoo Zone Puppies and provide proof that your puppy has been spayed or neutered. If this documentation is not provided within the required timeframe, Peekapoo Zone Puppies will contact you to request the missing information. **Once valid proof of spay or neuter has been submitted, Peekapoo Zone Puppies will then provide the Continental Kennel Club (CKC) Registration Form.**

In regards to the registration form, the owner will be able to yield authenticity. In the event that your dog is lost or stolen, this documentation serves as proof of ownership and may assist in their safe return. When you register your dog with the Continental Kennel Club (CKC), you will receive an official certificate verifying that you are the registered owner. Additionally, a puppy birth certificate provides the highest level of documented identification for your dog.

What happens if the contract isn't fulfilled?

Peekapoo Zone Puppies requires you to acknowledge and understand the consequences if you do not abide by the contract. If you think you are unable to execute it, then this is the moment to halt the process.

All of the families that purchase a puppy at Peekapoo Zone Puppies will hereby sign and complete the Responsible Pet Ownership Contract.

If you fail with the requirements of this contract Peekapoo Zone Puppies will have the right to bring your puppy back to our installations without any kind of refund. We will also file a civil lawsuit at the court of Nacogdoches county. The owner and co-owner of the puppy will be responsible for all the costs of the lawsuit. In addition, they will also be responsible for paying an amount of money that Peekapoo Zone Puppies will set in such a claim, which isn't determined at this time
